If a payment falls on a weekend or holiday, the deduction will occur on the next business day. A "business day" means Monday through Friday, excluding bank holidays. If a payment due date falls on the 29<sup>th</sup>, 30<sup>th</sup>, or 31<sup>st</sup> of a month, and such date does not occur in that month, then the deduction will occur on the last day of the month.

This authorization will remain in effect until all the payments due under the loan agreement are paid in full (except for the final payment on a retail installment or loan account which will be billed separately), or until JBT has received notification of termination from me (or either of us).
